DACA Renewal Checklist

- \$495 fee (money order) made payable to “Department of Homeland Security”
 - *[Note: Loan for \$495 fee at Second Federal Credit Union Available]*
- Two (2) passport photos
- A copy of all your Work Permits (If you have renewed more than one time).
- A copy of your previously filed DACA application (If you do not have this, you should contact the person who helped you ASAP for a copy)
- A copy of your passport (if you have one), state issued I.D., drivers license, OR Consular ID (Matricula) Card
- \$50 Money Order to “The Resurrection Project” for postage, processing costs, and copies and fill out the attached Informational Sheet.
- Any criminal or traffic records you have had in U.S.
