#### RAUL RAYMUNDO IS A LINCOLN LAUREATE!

TRP is proud to share that Raul Raymundo, CEO and Co-Founder of The Resurrection Project (TRP), was inducted as a Laureate of the Order of Lincoln on April 13. Presented by Governor JB Pritzker, this honor is known as 'the state's highest award' and is presented to "individuals whose dedication to the principles of public service inspire all Illinoisans". Raul received this honor alongside six other extraordinary Illinoisians, including Evelyn Brandt Thomas, Lewis Collens, Hon. Rita B. Garman, Alison Krauss, Lester H. McKeever, Jr., and James H. Thome.

Raul was honored to be introduced by longtime friend, collaborator, and community leader Ric Estrada of Metropolitan Family Services, who reflected that as "a mentor to many leaders across the city of Chicago and the state of Illinois, (Raul) continues to channel his energy into transformative solutions for change, strengthening opportunities for working class immigrant families."

**Mayor Brandon Johnson** recently joined a meeting with TRP, community leaders, long-term immigrants, and immigrant advocates to discuss the importance of recognizing the contributions made by Black and Brown communities. The goal is to acknowledge the significant contributions of 480,000 long-term undocumented immigrants who currently make up the workforce and contribute approximately \$1.5 billion in taxes to Illinois' economy and urge President Biden and the Administration to extend legal work permits for all undocumented.

#### Learn about property taxes and how to appeal

Over the last three years, property values have been on the rise in Chicago, which can make it difficult for homeowners to afford their homes and may lead to displacement or foreclosure. This year, in 2024, the city of Chicago will be reassessing home values.

If you're a homeowner, we invite you to join TRP's Housing Stability team to learn more about the Cook County <u>triennial reassessment</u>, possible exemptions, and how you can appeal your property taxes if necessary.

Attention all homeowners: it's important to note that the deadline to file for exemption savings for tax year 2024 is Monday, April 29. Please call our team at 312-666-1323 to make an appointment to review your property tax bill.

#### **NEW INITIATIVE! LEARNING LABS**

TRP's Immigrant Justice Leadership Academy has launched a new initiative called Learning Labs. The Labs will help nonprofits in Illinois to establish or grow their immigration clinics through a series of convenings, trainings, and peer learning.



#### THE PARENT MENTOR PROGRAM

TRP's Parent Mentor program is designed to empower parents to take an active role in their children's schools and communities. Through this program, Parent Mentors can learn how to assist inside the classroom and how strong communities can create strong schools. Currently, Parent Mentors are available at schools located in Pilsen and Back of the Yards.

### HOPE WRAPS UP FIRST YEAR OF EXPANSION IN BRIGHTON PARK

HOPE Family Services at the Resurrection Project's goal is to empower families and contribute to building healthy communities. We offer programs that promote personal growth, healthy marriages, and peaceful family life.

In 2017, we expanded our services from Pilsen to other communities such as Little Village, Cicero, West Lawn, Archer Heights, and Avondale. We deliver leadership development training and community education in various parishes located in these communities. Currently, these activities take place in three parishes: Mother of the Americas (Little Village), Our Lady of the Snows (Archer Heights), and St Nicholas of Tolentine (West Lawn).

In late 2022, our team pursued a grant opportunity from the Brighton Park Neighborhood Council (BPNC) to extend our services to low-income families in other neighborhoods with limited access to mental health services. HOPE was selected to provide free, bilingual (English/Spanish), and culturally appropriate domestic violence services to primarily serve Brighton Park residents.

In early 2023, we began offering services in Brighton Park and have now completed the first year of the BPNC grant, serving a total of 150 adults and 40 children. Through this opportunity, we have established a relationship with a fourth parish, Immaculate Conception-Five Holy Martyrs Parish. As we move into the second year of the expansion, HOPE is proud to announce that we have a solid range of direct services such as a men's group, a women's group, parenting classes, and individual counseling provided out of Immaculate Conception-Five Holy Martyrs Parish. We are grateful for the opportunity to serve families in Brighton Park and look forward to strengthening our partnerships with BPNC and Immaculate Conception-Five Holy Martyrs Parish in 2024.

#### **COMMUNITY PROGRAMS**

#### PROVIDING RESOURCES TO THE COMMUNITY

The Healthy Chicago Equity Zone (HCEZ) is an initiative led by TRP and its partners to increase mental health resources in the neighborhoods of Pilsen, McKinley Park, and Back of the Yards. The team of health navigators has been actively involved in community outreach events and resource fairs. They have collaborated with various organizations including the Ecuadorian Consulate, Benito Juarez High School, the Instituto Progresso Latino Feria, Lindblom High School, Lara Academy in Back of the Yards, and Senior Bingo at Casa Maravilla to help achieve their goal. The CHICAGO COMMUNITY HEALTH RESPONSE CORP. (CCHRC) is an initiative of TRP that connects TRP tenants and Chicagoans with public health employment and training opportunities to increase health resources in the community. We educate our community about COVID-19 and other public health threats in partnership with clinics, hospitals, and community organizations. The team presented to Chavez Elementary, Walsh Elementary and Fulton Elementary about anti-bullying, conducted CPR classes at Perez Elementary, and the team distributed Personal Protective Equipment (PPE) kits at the Pilsen Food Pantry and St. Pius.
